#### TGTF Payout Plan - February 26, 2024

Art Institute of Atlanta and Miami International University of Art & Design

Pursuant to O.C.G.A. § 20-3-250.27 and NPEC Policy 13: Tuition Guaranty Trust Fund (TGTF) Claims, the following are initial recommendations of NPEC for payouts from the TGTF by the Board of Trustees:

Eligible for Reimbursement	Stipulations
Application Fee	The TGTF will reimburse students for documented and verified application fees that were incurred due to the precipitous closures of the Atlanta and Miami campuses.
	The student must have been enrolled at the time of the closure to be eligible for this benefit.
Entrance Examination Fee	The TGTF will reimburse students for documented and verified entrance examination fees (e.g., GRE, GMAT, etc.) that were required by the transferring institution and incurred due to the precipitous closures of the Atlanta and Miami campuses.
	The student must have been enrolled at the time of the closure to be eligible for this benefit.
Lost Credit	The TGTF will reimburse students for documented and verified lost credit hours by the student due to transferring to a new institution. The cost of reimbursement will be at a rate equal to the credit hour cost at the closed institution. The student is only eligible for this benefit for credits lost transferring from one like program to another, based on the sole discretion of NPEC.
	The student must have been enrolled at the time of the closure to be eligible for this benefit.
Transcript Fee	The TGTF will reimburse students for documented and verified transcript fees that were incurred due to the precipitous closures of the Atlanta and Miami campuses.
	The student must have been enrolled at the time of the closure to be eligible for this benefit.

*Note.* Other eligible expenses may be determined to be valid by NPEC after further review. If so, items will be submitted to the Board of Trustees for consideration, review, and future approval.
