Executive Director Shook discussed the following:

- SunTrust waived fee to move the funds
- No fees to take out or move the funds
- Funds can be accessed in 24 hours
- No risk involved; customary State Treasury investment pool
- GNPEC will benefit with stronger interest earnings

Holly Kirbo made a motion to **APPROVE** the move of \$1 Million from GNPEC operating budget account to GNPEC's local government investment pool account. Toby Hinton seconded the motion.

Upon unanimous vote, it was **RESOLVED** that the move of \$1 Million from GNPEC operating budget account to GNPEC's local government investment pool account, be approved.
