4. APPROVAL OF MINUTES

The Commissioners reviewed the minutes from March 26, 2019 Special Called Meeting of the Georgia Nonpublic Postsecondary Education Commission and Commissioner Cohen suggested that the following sentences be grammatically changed:

Section number 5, under "The following approvals transpired" and section "E" read:

"Holly Kirbo motioned that the Commission move to **ADOPT** this "Future Process" of an ALJ hearing as an initial decision, subject to the Commission's final approval for the final decision as the 'Future Process", unless the Commission decides to change at any time.

Upon unanimous vote it was **RESOLVED** that the Commission adopt this "Future Process" of an ALJ hearing as an initial decision, subject to the Commission's final approval for the final decision as the "Future Process", unless the Commission decides to change at any time, **be adopted**."

This change was acknowledged.

5. DISCUSSION AND APPROVAL OF PROPOSED GNPEC SCHEDULE OF FINES FOR VIOLATIONS OF O.C.G.A.§20-3-250.7 or O.C.G.A.§20-3-250.8 OR FAILURE OR REFUSAL TO DEPOSIT RECORDS AS REQUIRED BY O.C.G.A.§20-3-250.17

Deputy Director, Dr. Laura Vieth presented, and the following was discussed:

- GNPEC law should be more precise with the specifics of fines to an institute who is in violation of relinquishing student records as requested
- Susan Haynes, Assistant Attorney General suggested that GNPEC propose a "schedule of fines" to assist with these violations
- Implementing these "schedule of fines" will assist in an ongoing case between CCME Training Services and GNPEC. CCME has not relinquished student records as requested by GNPEC.

The Commission reviewed the proposed Schedule of Fines and Chair Kirbo suggested that the following be added to the language of the Schedule of Fines:

Number "1", and section "d" should read: "Includes *violations of* directives to exempt institutions or those potentially eligible for exemption (O.C.G.A.§20-3-250.8).

This change was acknowledged.

Holly Kirbo made a motion to **ADOPT** GNPEC's Proposed Schedule of Fines for violations of O.C.G.A.§20-3-250.7 or O.C.G.A.§20-3-250.8 or failure or refusal to deposit records as required by O.C.G.A.§20-3-250.17. Norma Nunez-Cortes seconded the motion.

Upon unanimous vote it was **RESOLVED** that GNPEC's Proposed Schedule of Fines for violations of O.C.G.A.§20-3-250.7 or O.C.G.A.§20-3-250.8 or failure or refusal to deposit records as required by O.C.G.A.§20-3-250.17, **be adopted**.
